• Consolidated profit after tax in 2023 is 2,245 billion VND (of which profit after tax belonging to parent company's shareholders is 2,030.7 billion VND), increasing 668.47 billion VND compared to 2022 (profit after tax consolidated in 2022 is 1,576.53 billion VND). The reason for the increase in consolidated reported profit is mainly due

to the Company's increased revenue recorded from industrial parks' business activities compared to the previous year.

• The parent company's separate profit after tax in 2023 is 923.60 billion VND, increasing 312.86 billion VND (separate profit after tax in 2022 is 610.75 billion VND). The main reason for the increase in separate reported profit is because during the year, the Company recorded increased revenue from industrial parks' business activities compared to the previous year.
