• Consolidated Loss after tax in Quarter I/2024 was 76.7 billion VND, decreasing 1,133.1 billion VND compared with the same period in 2023 (of which profit after tax in Quarter I/2023 was 1,056.4 billion VND). The main reason is that in this period, the

Company recorded less revenue from industrial park business activities and did not record the financial income from investment transfer compared to the same period last year.

- The parent company's separate loss after tax in Quarter I/2024 was 149.10 billion VND, decreasing 296.59 billion VND compared with the same period in 2023 (separate profit after tax in Quarter I/2023 was 147.49 billion VND). The main reason is that in this period, the Company recorded less revenue from industrial park business activities and did not record financial income from investment transfer compared to the same period last year.
